**Sub:** - Resorting to Unfair Means during University Examinations **Ref:** - University Notification No. 18/2022

It is hereby notified for information of all the concerned examinees that, the University has declared the result of Ph.D. Entrance Test on the University website on 06/10/2022. However, the results of the examinees who have been resorted to Unfair Means in this examination (making marks on their question paper/mistakes in answer sheet etc.). has been withheld as per the provisions U/s 71.8 of University Ordinance No. 01/2014. The erring examinees may see the document in which he/she has committed Unfair Means by him/her by visiting the University on or before 14th October, 2022.

The Competent Authority after going through the Unfair Means conducted by the examinees, decided to impose fine/penalty of Rs.7,000/- (Rs. Seven Thousand) to each erring examinees and further giving them warning to be more careful in future and strictly follow the instructions during the University examinations.

The erring examinees are directed to submit the amount of fine/penalty in the form of Demand Draft in favour of "**The Registrar, M.U.H.S. Nashik**" payable at Nashik OR through the University portal / UPI (University A/c No. 00641450000649 IFSC : HDFC0000064) and submit the Challan generated to the University (e.mail : examadmin@muhs.ac.in) <u>on or before 17<sup>th</sup> October, 2022.</u>

The result of erring examinees shall be declared only after receipt of the amount of penalty on or before the prescribed period/date. The erring examinees who have been failed to submit the amount of penalty before the above stipulated date, shall be out from the admission process and their candidature for admission to Ph.D. cannot be considered under any circumstances.

Please take note of the above decision of the Competent authority of the University.
